### What does the fund invest in?

The objective of this Fund is to achieve long-term capital appreciation. The Fund's portfolio consists primarily of equity securities of companies located or operating primarily in Europe, Australasia and the Far East.

The Fund may invest up to 100% of its net assets in foreign securities and up to 20% in emerging markets securities.

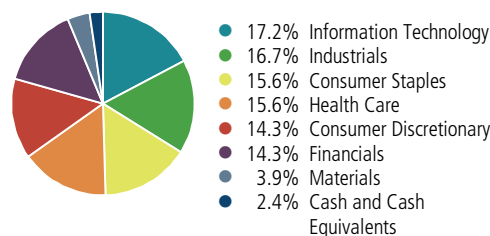

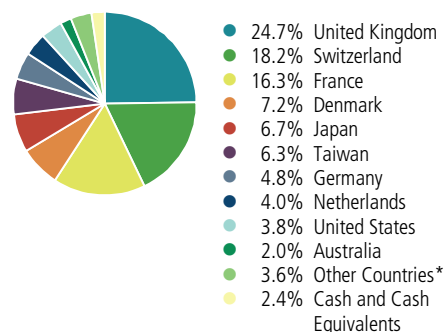

### How risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns.

Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

## Risk rating

Desjardins Investments Inc. has rated the volatility of this Fund as **medium**.

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

## No guarantees

Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

## How has the fund performed?

This section tells you how W - Class units of the Fund have performed over the past 2 years. Returns are after expenses have been deducted with the exception however of management fees paid to the Manager which may differ from one investor to another as they are negotiated by each one of them directly with the Manager. These expenses reduce the Fund's returns.

### Year-by-year returns

This chart shows how W - Class units of the Fund performed in each of the past 2 years. On an annual basis, the value of the Fund decreased during 1 year for the period shown. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



### Best and worst 3-month returns

This table shows the best and worst returns for W - Class units of the Fund in a 3-month period over the past 2 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

### Average return

A person who invested \$1,000 in W - Class units of the Fund since its inception holds today \$1,227, which represents an annual compounded rate of return of 7.53%.

## Who is this fund for?

### An investor who:

- is looking for long-term capital appreciation;
- wants to add a core international equity fund to his or her portfolio.

## A word about tax

In general, you will have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and on whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

## How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell W - Class units of the Fund. The fees and expenses — including any commissions — can vary among Class units of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

### 1. Sales Charges

W-Class units of the Fund are no load. That means you pay no initial sales charge and no deferred sales charge.

## 2. Fund Expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns.

On September 30, 2023, Fund expenses represented 0.06% of its value, or \$0.60 on each \$1,000 investment.

### More about the trailing commission

Desjardins Investments Inc. pays no trailing commissions to your representative's firm with respect to W-Class units of the Fund.

## 3. Other Fees

You may have to pay other fees when you buy, hold, switch or sell units of the Fund.

Fee	What you pay
<b>Management Fee</b>	Each investor pays reduced management fees, which he negotiates directly with the Manager of the Fund. As a result, the management fees are not included in the MER. When W-Class Units are detained by an investor that has reached a discretionary portfolio management agreement with its representative's firm, the reduced management fees are negotiated and payable directly by the representative's firm. Even if the management fees are negotiated, the maximum annual management fees payable by a W-Class investor or its representative's firm will not be greater than the maximum amount payable by an A-Class investor, which is 1.75%.
<b>Fixed Administration Fee</b>	W-Class units pay a reduced fixed administration fee, which is negotiated directly with each investor. When W-Class Units are detained by an investor that has reached a discretionary portfolio management agreement with its representative's firm, the reduced fixed administration fee is negotiated and payable directly by the representative's firm. Even if each investor or representative's firm pays the fees negotiated directly with the Manager, the maximum annual fixed administration fee payable by a W-Class investor will not be greater than the maximum one payable by an A-Class investor, which is 0.23%.
<b>Short-Term Trading Fee</b>	Up to 2% of the value of the units you switch or sell within 30 days of purchase. These fees are paid to the Fund.
<b>Switching Fee</b>	None
<b>Reclassification Fee</b>	None
<b>Additional Fees</b>	Please note that your representative's firm may charge additional fees. These fees might be negotiated with your representative.

## What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a Simplified Prospectus or a Fund Facts document; or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the Simplified Prospectus, Fund Facts document, Annual Information Form or Financial Statements contain misrepresentations. You must act within the time limit set by the securities law in your province or territory. For more information, see the securities law of your province or territory or ask a lawyer.
