## 2. Changes of Portfolio Sub-Manager for the Desjardins Enhanced Bond Fund

The Manager intends to terminate the mandate of Sanford C. Bernstein & Co., LLC ("Sanford C. Bernstein") as portfolio sub-manager of the Desjardins Enhanced Bond Fund. Desjardins Global Asset Management Inc., as Portfolio Manager of the Fund, will be responsible for the management of the portfolio assets on or about November 4, 2024.

## 3. Changes to the Investment Strategies of the Desjardins Enhanced Bond Fund

On or about November 4, 2024, the Manager will amend the investment strategies of the Fund in order to reflect the new investment philosophy of the Portfolio Manager.

The Manager reserves the right to delay implementing all or part of the changes described in this Amendment, or to refrain from implementing these changes at all.

## 2. Changes of Portfolio Sub-Manager for the Desjardins Enhanced Bond Fund

The Manager will terminate the mandate of Sanford C. Bernstein as portfolio sub-manager of the Desjardins Enhanced Bond Fund. Desjardins Global Asset Management Inc., as Portfolio Manager of the Fund, will be responsible for the management of the portfolio assets on or about November 4, 2024.

- a) Sanford C. Bernstein will cease to act as sub-manager of the investment portfolio of the Desjardins Enhanced Bond Fund. Consequently, the information in the sub-section related to "Sanford C. Bernstein & Co., LLC", under section "Portfolio Managers" under the heading "Responsibility for mutual fund administration" in part A of the simplified prospectus will be deleted.
- b) Desjardins Global Asset Management Inc., as portfolio manager of the Funds, will be responsible for the management of the investment portfolio of the Desjardins Enhanced Bond Fund. Consequently, the following information regarding the management of the Fund is added to the section "Portfolio Managers" under the heading Responsibility for mutual fund administration" of part A of the simplified prospectus:

Francis Scott is principally responsible for the portfolio advisory services provided to the Desjardins Canadian Bond Fund, <u>the</u> Desjardins Sustainable Canadian Bond Fund (formerly Desjardins SocieTerra Canadian Bond Fund), the <u>Desjardins Enhanced Bond</u> <u>Fund</u> and for fixed income securities portfolio advisory services provided to the Desjardins Dividend Balanced Fund (formerly Desjardins Dividend Income Fund). Mr. Scott is a "universe" type portfolio manager within the Fixed-Income team. He also manages various sustainable investment mandates. Mr. Scott joined the Portfolio Manager's team in 2007.

c) The following paragraph will be added to the "Major Events" column relating to the Desjardins Enhanced Bond Fund in the table found under the heading "Names, Formation and History of the Funds":

November 4, 2024 - the Manager terminated the mandate of Sanford C. Bernstein as portfolio sub-manager of the Fund and approved changes to the investment strategies of the Fund to reflect the investment philosophy of the Portfolio Manager.

d) The introductory table "Fund Details" in the Fund's profile document under part B of the simplified prospectus will be amended to remove the reference to "Sanford C. Bernstein & Co., LLC" and delete the section "Portfolio Sub-Manager".

## 3. Changes to the investment strategies of the Desjardins Enhanced Bond Fund

On or about November 4, 2024, the Manager will amend the investment strategies of the Desjardins Enhanced Bond Fund to reflect the new investment philosophy of the Portfolio Manager. Consequently, the investment strategies described under section "Investment Strategies" of the Fund's profile document under Part B of the simplified are amended as follows:

- a) all references to the term "sub-manager" mentioned under section "Investment Strategies" are deleted and replaced by the term "Portfolio Manager";
- b) the first paragraph of section "Investment Strategies" is deleted and replaced by the following paragraph:

"The Portfolio Manager who, through credit research and economic analysis, combines fundamental and quantitative analyses in order to validate and optimize the opportunities that are available in the markets."

c) the following paragraph is added immediately after the first paragraph of section "Investment Strategies":

"The fundamental analysis of the economy and market anticipations allows the Portfolio Manager to establish a portfolio strategy in terms of timeframe, credit risk, interest-rate curve and sector allocation."

- d) the third paragraph of section "Investment Strategies" is also modified by deleting the following sentence "allowing the portfolio to benefit from the excess returns of these markets".
- e) the fourth paragraph of section "Investment Strategies" is deleted and replaced by the following paragraph:

"The Fund may invest up to 25 % of its net assets in foreign securities and up to 15% of its net assets in high-yield bonds."

f) the sixth paragraph of section "Investment Strategies" regarding the Fund's expected high portfolio turnover rate is deleted in its entirety. d

To reflect the change in the Fund's investment strategies, the heading "What Are the Risks of Investing in the Fund?" under Part B of the simplified prospectus for the Fund is amended by adding the Asset-backed securities and mortgage-backed securities risk and the High-yield risk to the list of secondary risks of investing in the Fund.
